#### **COVID-19 Mass Testing in School**

We have made a successful start to the programme of COVID-19 lateral flow tests in school. We have managed to initially test students in school twice within 3 days followed by regular weekly testing. We have also embarked on twice weekly testing for staff who are in school. Once school fully re-opens these tests will help to identify asymptomatic cases and limit the spread of Covid-19 within our school community and, along with our other protective measures, will help staff and students stay safe in school.

We are extremely grateful for the offers we have received so far from members of our school community volunteering to become part of the testing workforce. However, the extent of the testing programme we will be able to offer when the students return to school will depend on a number of factors, including staffing and resourcing. For us to achieve the levels of testing suggested by the Government we will need more people to join the workforce. ### Online Safety advice - In App Purchases



An in-app purchase is where a digital company asks for real-world money to buy additional content for games or apps. The boom of users demanding free apps has led to developers having to implement "in-app purchases" to make money. Over recent years this has led to a serious negative impact on users as these micro-transactions have been made addictive and built up over time, which could end up costing users hundreds or even thousands of pounds.

The growth of this business strategy has also led to paid apps offering additional microtransactions within them even if the game or app was bought at full price.

The main issues parents face is with free games that target children into making purchases that they are unaware of. There are many examples of this such as the "My Little Pony app" which offers users the chance to purchase 'gems' for a cost of £69.99. This can then be purchased with 1 click of a button if the device is not set up correctly. Some children have spent thousands of pounds in less than a day by clicking these microtransactions and parents may only find out after the bill has been released and the content used. The money spent can then be very hard to recover.

#### Ways to protect against in app purchases and microtransactions

#### Change the device settings

Before you let your child use a device, check the purchase settings to prevent them spending money without you knowing. All devices are different, however most offer features such as:

- Disabling all in-app purchases
- Creating a password that is required for every purchase
- Ticking a "Do not link card to account," or "Do not save card" button

#### Read app descriptions

Before you or your child download a game or app, check the description to make sure you're happy for your child to use it. Most apps will tell you if they offer in-app purchases or microtransactions.

#### If it's too late

Check your bills to see if money has been taken from your account, If this is without your knowledge or consent get in touch with the game developer, online store or platform provider to request further assistance.


